# **Bylaw Changes Approved by Majority:**

- Motion to accept addition to Article 9. Uniform by Jeff Colten and 2<sup>nd</sup> by Dave Poli:
  - All rated officials are required to wear the U.S. Lacrosse-Women's Division approved Umpiring uniform which consists of: Vertically stripped black and white collared shirt or jacket. Black Slacks or Black skirt/skorts/shorts for women and black shorts for men. Black socks with shorts, skorts or kilts and black socks with black pants or slacks. Solid Black hat/visor. Whistle, Red, Yellow and Green Cards, Yellow Flag, Stopwatch, Tape Measure, Pencil/Pen and Paper, Rule Book and Flipping Coin.
- Motion to accept Article 8. Annual Dues by Joanne Delauter and 2<sup>nd</sup> by Tom Tabosky:

    - The member wishing to vote by proxy must submit to the Executive Committee their reason for not being able to attend the meeting and vote in person a minimum of five (5) days prior to the membership meeting where voting will take place. The Executive will review each Proxy Vote submission on a case-by-case basis and will issue an approval or denial based on the reason submitted.
